The OBC candidates must bring the original OBC certificates enclosed with the application ( if asked for) as well as latest OBC certificate not more than one year old. The OBC certificates should have the non-creamy layer clause and should be as per format prescribed in Notification. 3. Candidates must ensure that their name, name of father and other particulars in their original certificates must match with entries made in their application form. In case of spelling difference in candidate's name/father's name in various certificates an affidavit to the effect these name are of same person should be produced. 1. SC/ST/OBC candidates must ensure that the address mentioned in their caste certificates tally with the entries of permanent address made by them in their application forms. 5. Employee ID. 6. Letter from controlling officer for attending the document verification.
